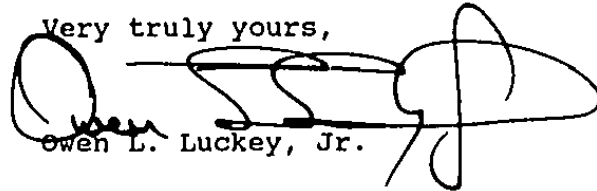

The name of this corporation is W S R ENTERPRISES, INC., a Florida corporation.

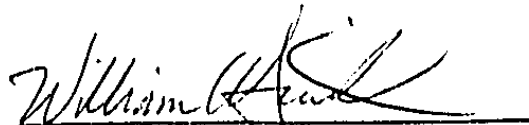

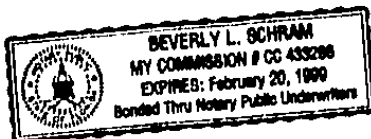
