The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is **SOLO MGMT OF NAPLES, INC.** The principal place of business of the corporation is 15084 Royal Fern Court, L-200, Naples, Florida 33963. The mailing address of the corporation is 15084 Royal Fern Court, L-200, Naples, Florida 33963.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.
