

The undersigned, acting as an incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation.

1. The name of the corporation is Telemonde Communications, Inc.
2. The address of the corporation is 321 23rd Street, Marathon, Florida 33050.
3. The period of its duration is perpetual
4. The purpose is to engage in the marketing of coin operated telephones and their subsequent installations, servicing telecommunications accounts, sales of telephones and other associated equipment and any other activities or business permitted under the laws of the United States and Florida.
5. The corporation shall have authority to issue five hundred (500) shares of stock, all on one class, One Dollar (\$1.00) per share par value.






