The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

# ARTICLE I

#### Name

The name of the corporation is NEVADA MANAGEMENT & PROMOTIONS, INC. and its address is 1523 S.W. 8th Street, Miami, Florida, 33135.

#### ARTICLE II

# Duration

The duration of the corporation shall be perpetual.

#### ARTICLE III

#### Purposes

The general purposes for which the corporation is organized are:

(1) To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

(2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
