

## ARTICLES OF INCORPORATION

OF

## ANTOJITOS 22-24 RESTAURANT, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

## ARTICLE I

The name of the corporation shall be:

### ARTICLE II

#### ARTICLE VI

The number of shares of stock that this corporation is authorized to issue is: One Thousand (1000) Shares of stock at ONE DOLLAR (\$1.00) Par Value Common Stock, which shall be designated "Common Shares". The Board of Directors may authorize the issuance of such stock to such persons upon such terms and for such consideration as thet may deem appropriate. The consideration may include money or other property, which property shall be received at just valuation to be fixed by the Board of Directors of this corporation. All of such stock, when issued, shall be fully paid for, and exempt from assessment.
