The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE ONE  
NAME

The name of the corporation is Florida Med-Care, Inc.

ARTICLE TWO  
PRINCIPAL OFFICE

The street and mailing address of the principal office of the corporation is 14313 S.W. 51st Street, Miami, Florida 33175.

ARTICLE THREE  
DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR  
PURPOSES

The general purposes for which the corporation is organized are:

1. To provide medical and pharmaceutical sales and management and consulting services.
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

3. To do such other things as are incidental, or are necessary or desirable in order to accomplish the above.

**ARTICLE FIVE  
CAPITALIZATION**

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class and shall have a par value of \$1.00.

The number of directors constituting the corporation's initial board of directors is 2. The name and address of each person who is to serve as a member of the initial board of directors is:



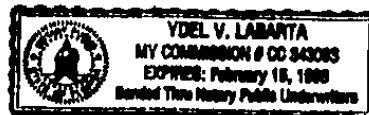
