ARTICLE I

The name of this corporation is **RURAL GARBAGE COLLECTION, INC.**

ARTICLE II

The corporation is to exist perpetually, on the date of execution and acknowledgment of these Articles.

ARTICLE III

This corporation is organized for the purpose of providing at the door residential garbage collection in unincorporated areas, and the transacting of any and all lawful business.

ARTICLE IV

This corporation is authorized to issue Two Thousand (2,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

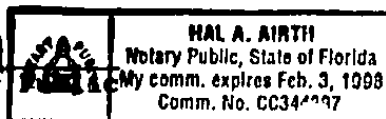
