# ARTICLES OF INCORPORATION OF

#### DIME STRIER, INC.

The undersigned, acting as Incorporator of a Corporation under the Flurida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

#### ARTICLE ONE

The name of this corporation shall be:
