ARTICLES OF INCORPORATION

S & D SPECIALTIES, INC.

We, the undersigned, hereby associate for the purpose of forming a Corporation under Chapter 607, Florida Statutes, 1993, and adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be S & D SPECIALTIES, INC.

ARTICLE II

The general nature of the business to be transacted by this Corporation is to engage in the business of carpentry, cabinet work, home construction and any other lawful business in the State of Florida; except that it is not to engage in or conduct a banking, safe deposit, trust, insurance, security, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, soutual fire insurance association, fraternal benefit society, state fair or exposition.

ARTICLE III

The maximum number of shares of stock that this Corporation shall be authorized to have outstanding at any time shall be One Thousand (1,000) shares of common stock; each share of One and No/100 (\$1.00) Dollar Per Value, fully paid and non-assessable. Subscription to stock shall be paid in such matter, and at such time, as the Board of Directors of this Corporation may, be resolution, require.

ARTICLE IV

The amount of capital with which this Corporation shall begin will \$\delta \cdot \text{One}\$

Thousand & 00/100 (\$1,000) Dollars.

ARTICLE V

This Corporation shall have a perpetual existence.

ARTICLE VI

ARTICLE XI

The Corporation shall indemnify any present or former officer or director, or person exercising powers and duties of a director, to the full extent now of hereafter permitted by law.

ARTICLE XII

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders, but the Board of Directors may not alter, amend or repeal any Bylaws adopted by the shareholders if the shareholders provide that the Bylaws shall not be altered, amended or repealed by the Board of Directors.
