

ARTICLES OF INCORPORATION

THE UNDERSIGNED, FOR THE PURPOSES OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, DOES HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE ONE

THE NAME OF THE CORPORATION IS MAJESTIC STAR SERVICES, INC.

ARTICLE TWO

THE DURATION OF THE CORPORATION IS PERPETUAL.
