Name**

The name of the corporation is **KILLIAN MARINE ASSOCIATES, INC.**

**Article II
Duration**

This corporation shall have perpetual existence.

**Article III
Purpose**

**Article IV
Capital Stock**

This corporation is authorized to issue 500 shares of stock at One Dollar (\$1.00) par value common stock.


**Article XIII
