**ARTICLES OF INCORPORATION OF
UNDER PRESSURE, INC.**

The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I
NAME**

The name of the Corporation is Under Pressure, Inc.

**ARTICLE II



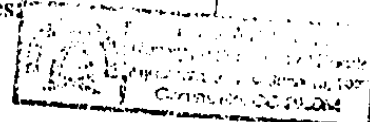
