ARTICALES OF INCORPORATION
OF
J-MAC INDUSTRIES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME AND PLACE OF BUSINESS

The name of the business shall be: J-MAC INDUSTRIES, INC. The principal place of business of the corporation shall be: 410 Mattie Stret, Sanford, Florida 32771.

ARTICLE II NATURE OF BUSINESS
