ARTICLE I. NAME AND ADDRESS. THE NAME OF THIS CORPORATION SHALL BE T & C's Conch Republic Divers, Inc., and its principal office is: 90311 Overseas Highway , Tavernier, Florida 33070.

ARTICLE II. DURATION. THIS CORPORATION IS TO EXIST PERPETUALLY.

ARTICLE III. PURPOSE. This corporation is organized for the Purpose of the transaction of any lawful business for which corporations may be incorporated under the laws of the State of Florida.


