The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, and who is licensed or otherwise legally authorized to render the professional services herein described, hereby forms a professional service corporation under Chapter 621 of the Laws of the State of Florida.

ARTICLE I NAME AND ADDRESS

The name of the corporation is THOMAS CARRASQUILLO, M.D., P.A. The principal business address of the corporation is 708 Del Prado Boulevard, Suite 8, Cape Coral, Florida 33990.

ARTICLE II NATURE OF BUSINESS

This corporation may engage in each and every aspect of the practice of medicine through the specialty of surgery but only through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services; and engage in any and every other activity permitted from time to time for a corporation so formed to engage in.

ARTICLE III CAPITAL STRUCTURE

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten thousand (10,000) shares of common stock of the same class each having a par value of One Dollar (\$1.00).
