# ARTICLES OF INCORPORATION

0F

#### GREENTREE LUMBER. INC.

THE UNDERSIGNED SUBSCRIBERS BEING NATURAL PERSONS COMPETENT OF CONTRACT HEREBY FILE THE FOLLOWING ARTICLES OF INCORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA, PROVIDING FOR THE FORMATION, LIABILITY, RIGHTS, PRIVILEGES AND IMMUNITIES OF A CORPORATION FOR PROFIT.

# ARTICLE I

NAME. THE NAME OF THE CORPORATION SHALL BE GREENTREE LUMBER, INC.

# ARTICLE II

DURATION. THIS CORPORATION SHALL EXIST PERPETUALLY.

#### ARTICLE III

PURPOSE. THE PURPOSE OF THIS CORPORATION IS TO HAVE AND EXERCISE ANY AND ALL POWERS NECESSARY OR CONVENIENT TO EFFECT ITS PURPOSES AND TO OTHERWISE ENGAGE IN ANY LAWFUL BUSINESS PERMITTED UNDER THE LAWS OF THE STATE OF FLORIDA.

## ARTICLE IV

CAPITAL STOCK.

THIS CORPORATION IS AUTHORIZED TO ISSUE

1,000 SHARES AT \$1.00 PAR VALUE STOCK. THE CONSIDERATION TO
