

We the undersigned, hareby associate ourselves together for the purpose of becoming a corporation under the latte of the State of Plevide, by and under the provisions of the States of the States of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

# ARTICLE I NAME OF CORPORATION The name of Corporation shall be: Ocean Food Mart Inc.

# ARTICLE II Ocean Food Mort Inc.

The general nature of the business and the objects and purposes proposed to be transacted, promoted and carried on are to do any and all things hereinafter mentioned as fully and to the same extent as natural persons might or could do, namely:

- (F) To acquire, retain, invest, exchange, purchase, soil, lease (as either lease or leaser), borrow, manage, plodge, transfer, convey, develop, manage, or otherwise deal in real and personal property within or without the State of Florida, any business incidental thereto and shall have such powers as incorporator, agent, shareholders, partner, member, associate, manager, and or florate of any Corporation, Partnership, clust venture trust and other enterprise within the scope of its status as S Chapter Corporation, under internal revenue code
- (G) To be engaged in Services such as Exports & Exports, Investments, Employment Agency, Real Estates, and such Services which are allowed by the State of Florida.
