The undersigned incorporators hereby file these Articles of Incorporation in order to form a professional service corporation under the laws of the State of Florida.

Name and Principal Office of Corporation

The name of this Corporation shall be Suarez & Perez-Tirse, M.D., P.A. The initial mailing address of the Corporation shall be 7000 S.W. 97th Avenue, Suite 203, Miami, Florida 33173.

ARTICLE II Nature of Business

The general nature of the business and activities to be transacted and carried on by this Corporation are as follows:

- (a) To carry on and conduct the practice of medicine under the laws of the State of Florida through individuals authorized by laws to render such services as individuals.
- (b) To transact all lawful business for which corporations may be incorporated under the Florida Professional Service Corporation Act, as hereafter amended and supplemented, and any successor statute thereto, as thereafter amended and supplemented.
