ARTICLES OF INCORPORATION

OF

FAT DADDY'S SPORTS BAR AND GRILL Inc.

We, the undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME AND DURATION

The name and address of the corporation shall be

This corporation shall have perpetual existence.

ARTICLE II

PURPOSES

The corporation is organized for the following purposes:

1. To engage in the business of retail sales and entertainment for the public.
2. To engage in or transact any other lawful trade or business.

### ARTICLE III

#### COMMENCEMENT OF CORPORATE EXISTENCE

Pursuant to Section 607.167 of the Florida General Corporation Act, the existence of this corporation shall commence on the date of subscription and acknowledgement of these Articles of Incorporation but not prior to April 1, 1995.

### ARTICLE IV

#### CORPORATE STOCK

The corporation shall have authorized capital of 100 shares of common stock with a par value of \$1.00 per share.

### ARTICLE V

#### INITIAL REGISTERED AGENT AND OFFICE

### ARTICLE VI

#### RESTRICTION ON TRANSFER OF STOCK

If, at any time, a majority or more of shareholders of the corporation enter into an agreement between and among themselves and the corporation to restrict transfer of the stock of the corporation, the corporation shall thereafter refuse to recognize any transfer of stock of the corporation unless the

same is in conformity with the terms and conditions of the agreement. The preceding sentence shall not apply unless a copy of such agreement is on file in the principal office of the corporation, and unless notice of the existence of such restrictions is noted conspicuously on the face or back of the certificate of stock. For purposes of this paragraph, the term "transfer" includes and sale, assignment or pledge of stock of the corporation.
