

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

#### ARTICLE I. NAME AND ADDRESS.

The name of this corporation shall be CRESTWELL SCHOOLS, INC. The principal business address of the corporation is 769 Vinca Way, Sanibel, Florida 33957.

#### ARTICLE II. DURATION.

The corporation shall commence April 7, 1995 and shall have perpetual existence thereafter.

#### ARTICLE III. PURPOSE.
