## CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION OF KORNER KOSHER MEATS-FLORIDA, INC.

CORE AND AND WE, the undersigned, President and Secretary, respectively, of KORNER KOS FLORIDA, INC., a corporation organized under the laws of the State of Florida, hereby ce follows:

- The original name of the corporation as it appears on the Certificate of Incorporation 1. filed with the Secretary of State of Florida on the 7th day of April, 1995, was KORNER KOSHER MEATS-FLORIDA, INC.
- That at a special meeting of the Board of Directors of said corporation held on the 2. 30th day of November, 1999, the Board of Directors unanimously resolved that the Amendment to the Certificate of Incorporation as contained herein be presented to the stockholders of the corporation for their action.
