ARTICLES OF INCORPORATION
OF
PALM BAY THERAPEUTIC MASSAGE CLINIC, INC.

ARTICLE I. NAME

The name of this corporation is
PALM BAY THERAPEUTIC MASSAGE CLINIC, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of
transacting any or all lawful business.

ARTICLE IV. CAPITOL STOCK

This corporation is authorized to issue 100 shares of

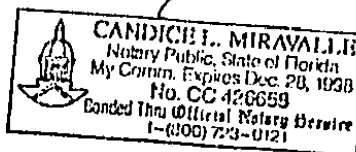


