OF

ARTICLE I. NAME. The name of the corporation shall be AERO-DYNAMICS OF CENTRAL FLORIDA, INC.

ARTICLE II. DURATION. The corporation shall exist perpetually.

ARTICLE III. PURPOSE. The purpose of this corporation is to engage in all aspects of aircraft ownership and leasing and to engage in any activity or business permitted under the laws of the State of Florida and of the United States of America.

ARTICLE IV. CAPITAL STOCK. This corporation is authorized to issue ONE THOUSAND (1,000) shares of common stock with One Dollar (\$1.00) par value per share, and the consideration to be paid for each share shall be fixed by the Board of Directors.
