**ARTICLE I  
NAME**

The name of this corporation is **AccuData Systems, Inc..**

**ARTICLE II  
DURATION**

This corporation shall have a perpetual existence commencing upon the filing hereof as provided by Florida Statutes, of these Articles of Incorporation by the Department of State.

**ARTICLE III  
PURPOSE**

The nature of the business or purposes to be conducted or promoted are: Development and distribution of computer-related data base applications and provide consultant services to provide both hardware and software computer-related solutions and any and all uses incidental and pertinent and associated therewith. continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.


#### ARTICLE XIV AMENDMENT


