ARTICLES OF INCORPORATION

FOR

TANGEN EXCAYATING, INC.

Strong St The undersigned acting as incorporators of a corporation under the Florida General Corporation act adopts the following Articles of Incorporation for their corporation.

ARTICLET

The name of the corporation shall be TANGEN EXCAVATING, INC. whose principal place of business is 203 107th Street, Marathon, Florida 33050.

ARTICLEII

The period of duration of the corporation is perpetual.

ARTICLE III
