Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation is MILLER, SOUTH & MILHAUSEN, P.A.

ARTICLE II. AMENDMENTS TO ARTICLES OF INCORPORATION

(A) Article I of the Articles of Incorporation is hereby amended to change the name of the Corporation to South Milhausen, P.A. by deleting the first sentence thereof and replacing it with the following sentence:

The name of the corporation shall be:
