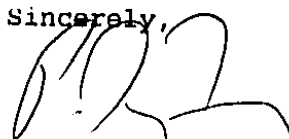

Name

The name of the corporation is **SHARK SERVICES, INC.**

Duration

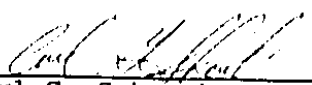
