ARTICLES OF INCORPORATION

OF

CHARLIE'S LANDSCAPING, INC.

ARTICLE I

The name of this Corporation is: Charlie's Landscaping, Inc.

This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.

ilability that might otherwine exist from thus contracting with this Corporation for the benefit of himself or any firm, association or corporation in which he may be anywine interested. Any director of this Corporation may vote upon any contract or other transaction between this Corporation and any firm, association or corporation in which he may be anywise interested.
