## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE OAKS PROMENADE, INC.

- A. The name of this corporation prior to the effective date of these Articles of Amendment is and was THE OAKS PROMENADE, INC.
- B. That the Amendments to the Articles of Incorporation are as follows:

That Article I of the Articles of Incorporation shall be amended to change the name of the corporation to: REEL CAPITAL VENTURES, INC., and the address of the corporation is 2050 East Oakland Park Boulevard, #209, Fort Lauderdale, Florida, 33306.

- C.
