ARTICLES OF INCORPORATION
OF
STERRETT PLUMBING AND ELECTRICAL OF NORTHWEST FLORIDA, INC.

The undersigned Incorporators, for the purpose of forming a Corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is Sterrett Plumbing and Electrical of Northwest Florida, Inc.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the Corporation is 3123 Lynny Lane, Marianna, Florida 32446, and the mailing address of the Corporation is 3123 Lynny Lane, Marianna, Florida 32446.

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

The Corporation is authorized to issue one class of shares, which shall be called common shares.
