**ARTICLE I - Name and Principal Office**

The name of this corporation is **THE INTERNET GROUP INCORPORATED** The principal office of this corporation is: 530 E. PINE STREET, TARPON SPRINGS, FL 34689-4008.

**ARTICLE II - Duration**

This corporation shall have perpetual existence.

**ARTICLE III - Purpose**

This corporation is organized to include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes (1993), as presently enacted and as it may be amended from time to time.

**ARTICLE IV - Capital Stock**

This corporation shall be authorized to issue Five Hundred Thousand (500,000) shares of common stock at \$.001 par value per share.
