ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LAKE CONSTRUCTION SERVICES, INC.

Pursuant to the provisions of Sections 607,1003 and 607,1006 of the Florida Statutes, LAKE CONSTRUCTION SERVICES, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

The name of the corporation is LAKE CONSTRUCTION SERVICES, INC.

The original Articles of Incorporation for the corporation were filed on April 11, 1995, and assigned Charter No. P95000028495.

By a written consent executed on March 27, 2006 by the sole director and sole shareholder, the sole director and the sole shareholder have approved an amendment to the Corporation's Articles of Incorporation increasing the number of shares of its authorized common stock from one hundred (100) shares with no par value common stock to one thousand (1,000) shares with One Cent (\$0.01) par value common stock. The amendment was approved by the sole director and sole shareholder of the Corporation, and the number of votes east for approval was sufficient.

Article III of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE III

The Corporation is authorized to issue one thousand (1,000) shares of common stock, one hundred (100) of which shall be voting common stock and nine hundred (900) of which shall be non-voting common stock. Each share of common stock of the corporation, whether voting common stock or non-voting common stock, shall have a par value of One Cent (\$0.01) per share.

Each holder of voting common stock shall have the right to vote with regard to all matters that must be approved and voted on by the shareholders of the corporation, including, but not limited to, the election of directors, and shall be entitled to one vote for each share of voting common stock held. Holders of non-voting common stock shall have no voting rights with respect to the corporation.

All holders of shares of common stock of the corporation, whether voting common stock or non-voting common stock, shall be entitled to receive the net assets of the corporation upon its dissolution and shall otherwise have identical rights and preferences with respect to distribution and liquidation proceeds.
