ARTICLE I – NAME

The name of this corporation is LAURIE L. SUQUET, P.A.

ARTICLE II – PURPOSE

This corporation is organized for the purpose of transacting the business of real estate sales, leasing, management, and other related real estate services.

ARTICLE III – CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class, and shall have a par value of \$1.00 per share.





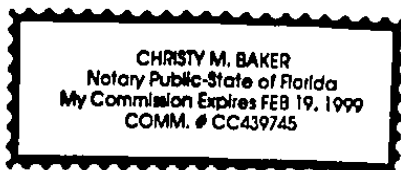
