This Amendment to Articles of Incorporation is filed pursuant to Florida Statutes 607.1006, to reflect an amendment to the Articles of Incorporation of Results Publishing, Inc., and in connection therewith, the undersigned officer, acting upon authority of the Board of Directors of Results Publishing, Inc., and upon authority of the holder of all the shares entitled to vote on said amendment, hereby set forth as follows:

1. The name of this corporation is Results Publishing, Inc.
2. The Articles of Incorporation of Results Publishing, Inc. are hereby amended as follows:

Article I has been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article:

"ARTICLE I. NAME AND DURATION

The name of the Corporation is SDI Wealth Institute, Inc.
The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State."

3. In accordance with Florida Statutes 607.0704, 607.0821 and 607.1003, the referred to amendment was adopted by Unanimous Written Consent of the Board of Directors and the Sole Shareholder on April 26, 1999, which unanimous consent was sufficient for the approval of the amendment.


