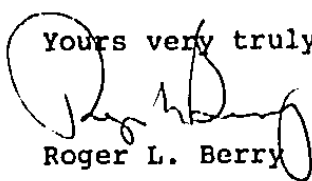

The undersigned, for the purpose of forming a corporation pursuant to the Florida General Corporation Act, Chapter 607, Florida Statutes, certifies:

ARTICLE I
NAME

The name of this corporation is H.M.C. AVIATION, INC.

ARTICLE II
DURATION

The duration of the corporation shall be perpetual.

ARTICLE III
ADDRESS PRINCIPAL OFFICE

The address of the initial principal office is 104 Riverside Drive, New Smyrna Beach, Florida 32168, and the mailing address is the same.

ARTICLE IV
PURPOSE

The general purpose and objective of this corporation is the operation of an aircraft brokerage for the retail and wholesale sale and purchase of aircraft and related parts and supplies and the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE V
CAPITAL STOCK

The capital stock of this corporation shall be divided into Seventy-five hundred (7,500) shares of common stock with par value of \$1.00 per share.
