**ARTICLES OF INCORPORATION  
FOR  
L. & RAP, INC.**

The undersigned, desiring to form a corporation in accordance with Chapter 607, Florida Statutes, the Florida General Corporation Act, adopt and file the following Articles of Incorporation.

**Article One  
NAME**

The name of this corporation shall be:

**Article Two  
PRINCIPAL OFFICE OF CORPORATION**




