ARTICLE I - Name

The name of this Corporation is Alegant By Christine, Inc. The principal place of business of this Corporation shall be 195 South Westmonte Drive, Suite E, Altamonte Springs, Florida 32714.

ARTICLE II - Duration

This Corporation shall begin existence on April 04, 1995 and exist perpetually.

ARTICLE III - Purpose

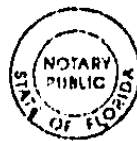
