ARTICLES OF INCORPORATION
OF
C D & G HOME IMPROVEMENTS, INC.

ARTICLE ONE NAME

The name of this corporation is C D & G Home Improvements, Inc.
(hereinafter referred to as the "Corporation")

ARTICLE TWO DURATION

The Corporation shall exist perpetually, commencing upon the filing of the
Articles of Incorporation with the Department of State

ARTICLE THREE PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful
business not inconsistent with the laws of the State of Florida

ARTICLE FOUR CAPITAL STOCK

The Corporation is authorized to issue 1,500 shares of One Dollar (\$1.00)
par value common stock

ARTICLE FIVE PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of the
Corporation of the same kind, class, or series as that which he or she already
holds, shall have the right to purchase his or her pro rata share thereof (or as many
as may be done without issuance of fractional shares) at the price at which it
is offered to others

ARTICLE SIX INITIAL REGISTERED OFFICE AND AGENT

ARTICLE TEN - BYLAWS

It is the intent of this charter that the Directors may sell the capital stock of the Corporation in accordance with the conditions of Sections 1242-1244, *et seq.* of the Internal Revenue Code of 1986, as amended.

The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law

ARTICLE THIRTEEN AMENDMENT

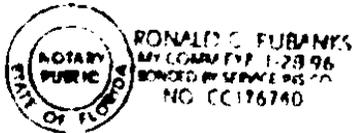
