**ARTICLES OF INCORPORATION
OF
COLLEGIATE STORAGE SERVICES, INC.**

ARTICLE I - NAME

The name of the corporation is **COLLEGIATE STORAGE SERVICES, INC.**, located at 3301 S.W. 65th Avenue, Miami, Florida 33155.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock. The owners of all issued and not issued stock shall be as follows:


