All shareholders of the corporation shall be vested with full pre-emptive rights.

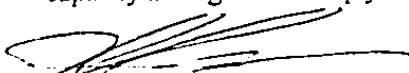

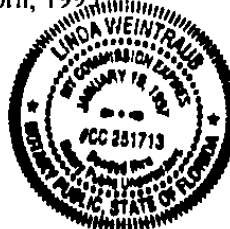
