WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the Laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

The corporation may engage in any activity of business permitted under the laws of the United States and of the State of Florida :
