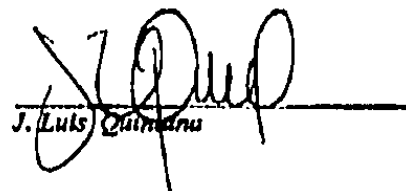
ARTICLE XI - OFFICES

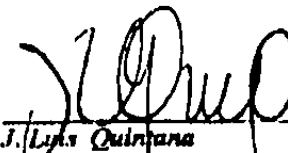
