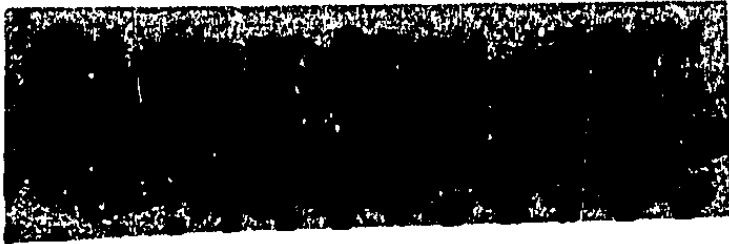

ARTICLES OF INCORPORATION

OF

CATHERINE W. PATRICK, PHD., P.A.

The undersigned, being of legal age, does hereby form the following corporation under the laws of the State of Florida, authorizing the formation of corporations.

ARTICLE I

NAME

The name of the Corporation Shall be:

CATHERINE W. PATRICK, PHD., P.A.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted by the Corporation and its objects and powers shall be as follows:
To engage in the activity of hematology and immunology and other such services as permitted under the Laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCK

1. The maximum number of shares of authorized capital stock of this Corporation shall be One Thousand (1000) shares of common stock with a nominal par value of One (\$1.00) Dollar.

2. The capital stock may be paid for in property, labor, services or cash. All of such stock shall be fully paid and non-assessable.

ARTICLE IV

INITIAL CAPITAL

ARTICLE V

ARTICLE VI

TERM OF EXISTENCE

The term for which this Corporation shall exist shall be perpetual.

ARTICLE VII

ADDRESS
