ARTICLES OF INCORPORATION SOUTHEASTERN CONSTRUCTION MANAGERS, INC. 95 APR 13 TH 20 20

The undersigned, acting as sole incorporator, desiring to form a corporation for profit of all and a pursuant to the Florida Connect Comment to the Florida Connect Connec pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1 - NAME OF CORPORATION

The name of the corporation shall be Southeastern Construction Managers, Inc.

<u> ARTICLE II - TERM OF EXISTENCE</u>

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE III - GENERAL PURPOSES

The general purpose for which the corporation is organized shall be:

ARTICLE V - INITIAL REGISTERED OFFICE, PRINCIPAL PLACE OF **BUSINESS AND REGISTERED AGENT**
