OF

## ARTICLE I NAME

3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.



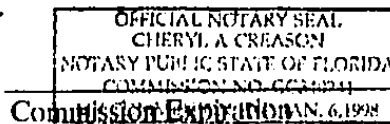
