ARTICLES OF INCORPORATION

OF

SOLAR DESIGNS, INC. A Florida Corporation

ARTICLE I

The name of the Corporation is: SOLAR DESIGNS, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE
