ARTICLES OF INCORPORATION

OF

ZORN'S MARINE SERVICES, INC. A Florida Corporation

ARTICLE I NAME

The name of the Corporation is: ZORN'S MARINE SERVICES, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 477 Flamingo Drive, Apollo Beach, FL 33572.

The principal mailing address of this corporation shall be: 477 Flamingo Drive, Apollo Beach, FL 33572.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

- 1. To engage in the business of providing marine repair and service. Service shall include labor only projects; all parts and materials will be the responsibility of client.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
