The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE: CORPORATE NAME

The Corporation name is MKA INTERNATIONAL, INC.

ARTICLE TWO: DURATION

The duration of the Corporation is perpetual.

ARTICLE THREE: PURPOSE OF CORPORATION

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.
