ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is Chriscraft Hair and Nail Salon, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in the business of hair design, and for the purpose of transacting any and all lawful business not inconsistent with the laws of the State of Florida.

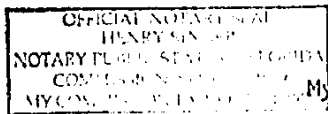


