ARTICLE I - NAME

The name of this corporation is: Magic Touch Services, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes: The general purpose for which this corporation shall be organized shall include the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida statutes. Principal Activity of the corporation will be to offer cleaning services and any other service that is lawful in the state of Florida.





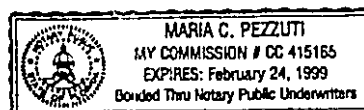
